Geon is tydens die onlangse *Silwer Skermfees* met die toekenning, 'Beste manlike byspeler in 'n drama' in die reeks 'Nêrens, Noord-Kaap', vereer. Glo dit gerus, maar hierdie befaamde akteur se 'akteursloopbaan' het reeds in Laerskool Gansbaai begin!

Na skool is hy vir twee jaar na London om homself verder met towerkuns op te skerp, iets wat hy reeds vanaf kindsbeen geniet het - in London het hy dan ook as towerkunstenaar gewerk.

“Op 'n dag het my ma my geskakel en gevra wat is my toekomsplanne,” vertel Geon. “Later het sy weer geskakel en gesê sy skryf my aan die Universiteit van Stellenbosch in vir 'n graad in drama. Hy

sê hy het toe gedink dis 'n goeie idee om sy towerkuns met drama te kombineer! Hy verwerf sy Drama-graad met lof en sy Honneursgraad daarna - “en dis waar alles begin het,” vertel hy, “en, o-ja, in 2008 het ek vir twee jaar as bestuurder en toergids vir 'n oorlandmaatskappy deur Afrika gereis!

Ons verken Botswana en Namibië - Deel 7-

In Deel 7 gaan ons voort met die egpare Fanie en Judy Bothma (toerleiers) van Franskraal, en Dolf en Elna Nel van Saldanha, se reis deur Botswana en Namibië (8 Mei tot 27 Junie). Elna Nel se kunstige dagboek, *BOT-NAM Avontuur*, bly 'n bron van uitstekende inligting. Soos vorige toere, is ook hierdie toer 'n ontdekkingsreis van begin tot einde.

Hulle verken verder en soek na woestynolifante, kameelperde en ander diere. Toe hulle die Sondagoggend in die rivierloop uit die daktente klim, ontdek Dolf vars olifantspore reg langs sy voertuig - spore wat nie die vorige aand daar was nie. Ná die vorige aand se kameelperd wat naby hulle gewei het, is die egpare baie opgewonde en vertrek om na meer diere in die rivierlope en tussen die berge te soek. "Ek kon nooit gedink het dat woestynland soveel mooi berge het nie," was Dolf se opmerking.

Hulle ry gemaklik in die rivierbedding van die Hoarusibrivier en kom op kameelperde af wat rustig aan die bome vreet. Hulle vertoef en geniet die rustigheid in die mooi kameelperde. By Puros Bush Lodge aangekom, is hulle verras met 'n pragtige en gerieflike lodge. Hulle ry verby die Harondia-en Omenye-kampeertreine, met Puros net 'n entjie verder. Ná 'n gesellige piekniek ry hulle na Sesfontein. Vanaf Sesfontein ry hulle na Ongongo Waterfalls & Hotspring. Dit is 'n baie mooi kampplek wat in die rivierbedding gebou is. Daar word in die helderskoon warmpoel tussen die kranse geswem, met die waterval wat daarin val. 'n Heerlike ete met biefstuk op die kole word voorberei voor hulle gaan stort. Op pad terug na Sesfontein die volgende dag, stop hulle by 'n bakkerij met die interessante naam: *Bakery & Tyre Repairs!*

Die voertuie mik nou na die Hoanibrivier, en by die Hoanib Trail Entrance Gate koop hulle 'n oornagpermit. 'n Piekniek word weer gehou in die pragtige rivierbedding. Met die

verder ry sien hulle hom... 'n woestynolifant wat baie rustig naby hulle staan en uitreik na die hoë boomtakke - wat 'n voorreg! Hulle ry nog baie kilometers verder in die breë rivierloop af en kry 'n lekker "wild camping"-staanplek om te oornag. Genoeg hout verseker 'n lekker vuur met potjiekos op die kole. Judy het die nag 'n veraf leeu gehoor, maar hulle het niks gesien nie - al is hulle by die ingang daarop attent gemaak. Die volgende oggend ry hulle weer in die rivierloop, en skaars het hulle vertrek of daar is hulle: "olifante vir Afrika" - vier koeie en drie kalfies. Die olifante vreet rustig, en daar word lank vertoef vir foto's en video's. Verder in die rivierloop sien Judy 'n nuwe voëltjie: 'n ringnekstrandkiewiet.

Ná 'n moeilike pad kom hulle moeg en stowwerig by Brandberg White Lady Lodge aan. Dit is 'n netjies ingerigte lodge met grasperke, 'n restaurant, swembaddens en heerlike kos. Die kampplekke is groot, wyd uitmekaar gespasieer en netjies ingerig met ablusiegeriewe. Die volgende dag word die White Lady-rotstekening besoek. Die gids wat hulle op 'n staptog van 2,5km neem, sê Brandberg is die hoogste berg in Namibië. Die rotstekening is in 1928 deur 'n Duitse geoloog ontdek. Die *White Lady* is 'n tekening waarvan die torso, arms en bene wit is, anders as al die ander tekeninge. Vandaar die bewering dat dit 'n wit vroulike figuur is. Tog is dit nie 'n vroulike figuur nie, maar eerder 'n *shamaan* (spirituele figuur) wat só uitgebeeld is.

Daarmee kom ons aan die einde van Deel 7. In Deel 8 verken die egpare verder vanaf Spitskoppe en daarna.

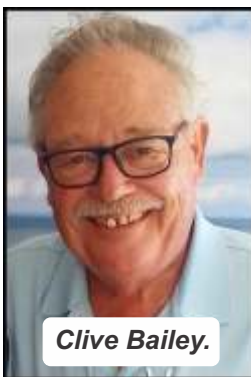

Op 3 Sept 2025 het ons nog 'n Erelid verloor - Jan “Links” le Roux, wie een van die stigterslede van Gansbaai Gholfklub was. Hy was 'n Komiteelid in 1998, en was die eerste persoon wat 'n gholfkarretjie gekoop het sodat hy genoeg gholf kan speel. 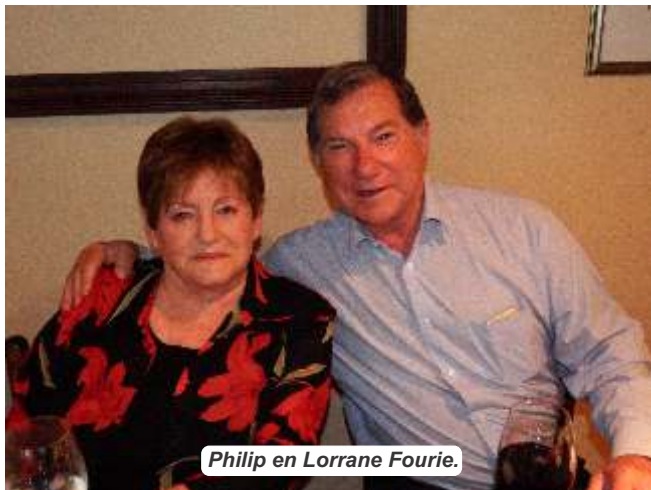

All members of the Valuation Appeal Board will be appointed by the Provincial Minister of Local Government, Environmental Affairs and Development Planning ("the Provincial Minister") in terms of section 58(2) of the MPRA, taking into account the need for representivity, including gender representivity, and after following due process.

Pursuant to section 64 of the MPRA, the Provincial Minister may appoint alternate members of the Valuation Appeal Board to act as members of the Valuation Appeal Board when a member is absent, has recused himself or herself, or is suspended, or when the filling of a vacancy on the Valuation Appeal Board is pending. Any person appointed as the alternate for the chairperson of the Valuation Appeal Board must be a person with legal qualifications and sufficient experience in the administration of justice (e.g. sufficient experience as a judge, magistrate, other judicial officer, chairperson of a statutory tribunal or body, or any other person with similar experience).

In line with regulation 7(3) of the Municipal Property Rates Regulations, 2006, members of the Valuation Appeal Board will, as far as possible, be appointed from within:

- The jurisdiction of Overstrand Municipality or
- If this is not possible, the jurisdiction of neighbouring municipalities, even if a neighbouring municipality falls within the jurisdiction of another province (with due care being given to the distances members will travel to and from their homes to hear appeal cases).

The term of office of members of a valuation appeal board is four years, but members are eligible to be re-appointed.

In line with section 59(1) of the MPRA, any person who falls within one or more of the following categories is disqualified from being appointed as a member of a valuation appeal board:

- (a) An unrehabilitated insolvent;
- (b) A person under curatorship;
- (c) A person declared to be of unsound mind by a court of the Republic of South Africa;
- (d) A person, who after 24 April 1994, was convicted of an offence and sentenced to imprisonment with an option of a fine for a period of not less than 12 months (provided that such disqualification ends five years after the imprisonment has been completed);
- (e) A person who has been disqualified in terms of applicable legislation from practicing as a valuer or lawyer; or
- (f) A person who is in arrears to a municipality for rates or service charges for a period longer than three months.

FUNCTIONS OF THE VALUATION APPEAL BOARD

The functions of the Valuation Appeal Board for Overstrand Municipality are the following:

- To hear and decide appeals against the decisions of a municipal valuer concerning objections to matters reflected in, or omitted from, the valuation roll of Overstrand Municipality in the following areas for which the Valuation Appeal Board was established: All areas within the jurisdiction of Overstrand Municipality.
- To review decisions of a municipal valuer submitted in terms of section 52 of the MPRA; and
- All other functions provided for in the MPRA.

REMUNERATION

Remuneration payable to members of the Valuation Appeal Board will be determined annually in accordance with the remuneration tariffs approved by the Minister of Finance for non-official members of commissions of inquiry in terms of regulation 20.2.2 of the National Treasury Regulations. The current maximum remuneration payable per day and per hour to non-official members of commissions of inquiry (which include non-official members of valuation appeal boards) are, with effect from 1 April 2022 as follows:

- Chairperson: R5,607.00 per day / R701.00 per hour; and
- A member other than a chairperson: R4,169.00 per day / R521.00 per hour.

Travel allowances payable will be determined with reference to applicable national tariffs of the Department of Transport.

APPLICATION REQUIREMENTS

Each application must contain at least the following:

- A clear indication of the position on the Valuation Appeal Board to which the application relates. Where the applicant intends applying as a Professional Valuer or Professional Associated Valuer, this must also be indicated in the application;

- A clear indication of whether the application only concerns appointment as an alternate member of the Valuation Appeal Board and, if so, a clear indication of which position on the Valuation Appeal Board the application concerns (e.g. alternate member for the chairperson). Where no indications are made in this regard, it will be assumed that the application does not concern alternate member positions;
- An unabridged CV detailing the applicant's knowledge, experience and suitability for the position;
- Certified copies of the applicant's qualifications;
- Certified copies of the applicant's professional registration (if applicable);
- A certified copy of the applicant's ID document / passport (copies of driver's licences are not acceptable); and
- An original copy of the Declaration of Eligibility duly completed and signed by the applicant (copies of the Declaration of Eligibility are available from the municipal offices of Overstrand Municipality or may be downloaded via <https://overstrand.gov.za>

Catch and release helps conservation

Catch and release helps to conserve the Western Cape's indigenous fish. Freshwater ecosystems across the Western Cape are rich in biodiversity, supporting a variety of indigenous fish. However, these species are increasingly threatened by the spread of invasive alien fish species, that prey on indigenous species and compete with them for food, space, and breeding grounds. These subtle shifts in ecological balance are often difficult to detect, but they have lasting consequences for the long-term health of freshwater ecosystems.



Currently, 24 of the province's 35 freshwater fish species are listed as *Threatened* and 73% of the Western Cape's freshwater fish are found nowhere else in the world. This high level of endemism makes local conservation efforts especially important. At the same time, 73 of 138 freshwater ecosystems in the Province have been classified as *Critically Endangered*, highlighting the need for science-based solutions to protect these habitats. To support the long-term health of these fragile systems, CapeNature is promoting catch and release fishing practices of indigenous fish species, and removal of invasive fish species as a practical and immediate way for recreational anglers to contribute to conservation.

"We want to empower communities, anglers, and visitors to become environmental stewards for our indigenous fish species," said Dr Ashley Naidoo, CEO of CapeNature. "Practicing responsible catch and release or sometimes catch and remove for alien invasive species helps to sustain the biodiversity and ecological balance of our freshwater systems." A recent survey conducted in the Boland Mountain Complex, which includes protected areas like Jonkershoek, Hottentots-Holland, Hawequas and Theewaterskloof, found that over half the surveyed

river sites were in 'Good' or 'Very Good' ecological condition. This is encouraging, but the presence of invasive fish at some sites remains a challenge for the survival of certain indigenous species. The Endangered giant redbfin (*Pseudobarbus skeltoni*) was confirmed for two of the three known populations but remains under pressure due to the presence of invasive fish. The catch and release approach helps reduce fishing pressure on indigenous fish populations, especially those that are already vulnerable or have limited ranges. When done correctly, it gives fish a chance to recover, breed, and contribute to the resilience of their ecosystems.

CapeNature is continuing to monitor river health through biodiversity surveys and is using the data to guide conservation action. Simultaneously, the Entity is encouraging behavioural change among fishing communities, outdoor enthusiasts, and local stakeholders by broadening the scale and scope of different public awareness efforts. These initiatives and their progress are reflected in resources such as the 2025 State of Conservation Report.

The Entity encourages all recreational anglers to familiarise themselves with indigenous species, use barbless hooks, minimise handling, and return fish to the water gently. These small actions can make a big difference in conserving the province's unique freshwater biodiversity. By combining science, community awareness and practical action, we're building long-term capacity to protect our freshwater fish species and the systems where they play critical roles.

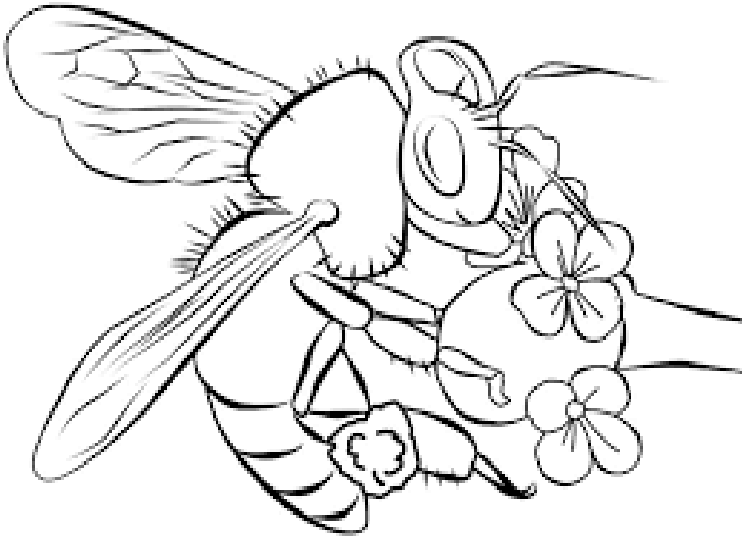
